In 2004, the Firm was also named Product Liability

Department of the Year by *The American Lawyer*, as well as a top-five finalist for Litigation Department of the Year. Thomson Financial, one of the foremost authorities on financial industry performance, ranked Jones Day number one for number of M&A deals completed worldwide in each quarter since the end of 2000.
