**The Firm:** This US law firm's China construction team is predominantly based in Beijing, although it also has capacity in the firm's Shanghai office. Particularly noted for its work for US companies investing in China, the team

also offers expertise in representing a range of other foreign investors and multinationals, construction companies and engineers in connection with construction projects in China. In addition, it is increasingly representing large Chinese corporates, construction companies and engineers in relation to overseas construction projects. Although the bulk of the practice's work is non-contentious and involves advising on construction and engineering issues connected with infrastructure and major projects, the lawyers also assist with construction disputes and dispute avoidance. **The Lawyers:** Head of the firm's Greater China construction practice, **Ashley Howlett** works out of the Beijing office and was described by

interviewees as "*probably the most famous foreign construction lawyer you'll come across in China.*" He was also noted for his recently published text on Chinese construction law, '*PRC Construction Law – A Guide for Foreign Companies*'. Highlight work for Howlett includes advising Hitachi Global Storage Technologies on the USD500 million construction of a new computer memory components manufacturing facility in Shenzhen.

**The Firm:** Three partners and seven associates give this firm a secure foothold in dispute resolution. The outfit is best known for its comprehensive transactional coverage, but it is working hard to bolster its litigation ability. Supported by an international network, the team has been active in some of the leading projects-related disputes. In arbitration, it is

praised for not only reaching favourable results, but also successfully enforcing judgments before domestic courts. Elsewhere, the group has flourished on insurance disputes, white-collar crime and IP. Clients rate the outfit as “*one of the more important law firms*,” and commend the team for its “*very structured approach and great teamwork*.”

**The Lawyers:** **Victor Chang** is a multi-talented lawyer with a Taiwanese, US and Chinese education. His work includes major arbitrations, IP and white-collar crime. Clients say that “*he is assertive and direct*” and “*he has an intellectual style, coupled with the ability to analyse the situation quickly, get to the crux of the problem and find the solution*.” Described as “*a pleasure to work with*,” **Marianne Chao** garners praise for her work in arbitration, construction disputes and general civil litigation. Clients find her straight approach refreshing: “*I appreciate her accurate summary of the situation - she is always excellent at explaining even difficult things*.” **Jason Chen**

**Clients/Work Highlights:** The team defended Matra Transport (now part of Siemens) against a claim brought by the Department of Rapid Transit Systems, and helped enforce an arbitral award in Matra’s favour. The group assisted the firm’s corporate team with the first hostile public takeover case in Taiwan, acting for China Development Financial Holding, and advised the management of SYSTEX, a shareholder in the joint venture company operating Taiwan’s freeway electronic toll collection system, on legality issues pertaining to the joint venture. A highlight in the insurance field was the team’s representation of Hiep Phuoc Power (a power plant in Vietnam) in a civil appeal to the Taiwan High Court.
